## KENDO EXAMINATION /SHINSA 1-5 Dan,

1. In the context of 10th Thessaloniki Kendo Cup 2016, (28-30/10/2016), HKINF will conduct a Kendo examination 1-5 Dan Kendo, on Sunday 30 October 2016, following the end of the competition, in Kolindros Sport Center, Kolindros, Pieria (Northern Greece). HKINF Secretariat will organize the examination.

2. Examination committees will be composed by invited teachers and HKINF senior members.

3. For a smooth conduct of the grading the following instructions are provided:

a. Candidates should have the minimum required time between examination; 6 months, 1 year, 2 years, 3 years, 4 years from Ikkyu, 1 Dan, 2 Dan, 3 Dan and 4 Dan respectively.

b. Application Forms should be received by HKINF General Secretary Spiros G. Drossoulakis, through e-mail [eokin.sec@gmail.com](mailto:eokin.sec@gmail.com) , by Wednesday 5 October 2016. Following that date no application will be accepted. For non HKINF members a written authorization from their respective Federation President is MANDATORY.

c. Candidates should on Saturday 29 October 2016 provide HKINF Secretary written President's Authorization (non HKINF members), EKF Yellow Card for Shodan and higher and pay the relevant examination fee (1 dan 20 €, 2 dan 25€, 3 dan 30€, 4 dan 40€, 5 dan 50€)..

d. Immediately following the examination, successful candidates should pay the relevant Registration Fee (Nikyu 15€, Ikkyu & 1 dan 10 €, 2 dan 15€, 3 dan 20€, 4 dan, 50€, 5 dan 70€). Failure to do so may cancel any successful results.

e. A minimum number of three candidates for Yondan and for Godan grading is required, for the proper conduct of the examination. In case of less number of candidates the relevant examination will not take place.

f. Participation at the seminar is mandatory for any grading candidates. Registration and payment of seminar fees should be done through the event organizers.
